### Dr. James Burrows Edwards 1927-2014

South Carolina and the Medical University of South Carolina lost one of its finest leaders on December 26, 2014. Dr. James B. Edwards will forever be remembered as a principled leader, who possessed a genuine heart that was always full of caring and concern for his fellow man. He always had kind words of encouragement and support for all of those around him. Dr. Edwards made each one feel that they indeed were special. His genuineness, combined with his gracious humility helped define his character. His death leaves a tremendous void in all of our lives.

James B. Edwards was born in Hawthorne, Florida in 1927 to O.M. and Bertie Hieronymus Edwards. Both parents were school teachers, and their careers led them to the South Carolina lowcountry in 1935. As a youth, Jim developed a love for the military and the sea while living in Mount Pleasant, South Carolina.

Upon his graduation from Moultrie High School at age 17 in 1944, he had to secure his parents' written permission to be able to serve in the United States Maritime Service(the Merchant Marine) during World War II. During his three years in the service, he worked his way up from ordinary seaman to becoming a licensed Merchant Marine officer by age 19. He was licensed to pilot ships of any tonnage on any water in the world.

Upon his discharge from the Maritime Service, he began his college studies at the College of Charleston, where he graduated in 1951. During his college years he remained active in the seafaring trade during the summer months delivering cargo across the Atlantic as well as to South America.

After college Jim Edwards attended the University of Louisville School of Dentistry and graduated there with his Doctor of Dental Medicine degree in 1955. While at Louisville he was the president of the dental school student body, as well as president of the University of Louisville Student Government.

Dr. Edwards then entered the United States Navy for two years as a member of the Dental Corps. Afterwards he served in the Navy Reserves until 1967, rising to the rank of Lt. Commander.

From 1957 to 1958 he studied at the University of Pennsylvania in Advanced Correlated Clinical Sciences. This was followed by an Oral Surgery residency at Henry Ford Hospital in Detroit, Michigan from 1958 to 1960.

Dr. Edwards returned to Charleston in 1960 and practiced Oral and Maxillofacial Surgery until 1974 when he became Governor of the state of South Carolina.

Politics began to enter Jim Edwards' life in the 1960s. He was the Chairman of the Charleston County Republican Party from 1964 to 1969, as well as the Chairman of the First Congressional District Republican Committee from 1970 to 1971. Dr. Edwards was elected as a state senator over a veteran incumbent in 1972. In 1974 he ran as a candidate for governor in South Carolina, overcoming tremendous odds in both the Republican primary and the general election to become the first Republican governor since the days of Reconstruction. As governor, he was known for his ability to work across party lines to achieve a consensus for legislation. Governor Edwards' administrative skills exhibited steady progress in public education, fiscal stability, and government reforms. He created a new emphasis marketing South Carolina to potential industrial manufacturing companies to locate here in our state. In 1978 Governor Edwards was elected as the Chairman of the Southern Governors Conference, an alliance of all the southern states' governors.

Because South Carolina's laws limited governors to one four year term, Dr. Edwards returned to his oral surgery practice in Charleston in 1979.

But national politics intervened, and President Ronald Reagan appointed him to the cabinet level post of Secretary of Energy in his administration in 1981. Dr. Edwards served there until late 1982, when Charleston beckoned for him to return as the new president of the Medical University of South Carolina.

As the leader at the helm at MUSC, Jim Edwards oversaw an explosive growth of the physical plant to triple the amount of floor space. Over \$240 million dollars were spent on construction and capital improvements. The number of endowed chairs went from just a handful to well over 100 chairs. Dr. Edwards' leadership and vision transformed MUSC into a nationally rated hospital facility. Along fundraising endeavors, he substantially increased alumni support, as well as started the first capital campaign to raise funds to improve the different schools and hospital. He was a tireless worker with his fundraising activities. After his retirement at the end of 1999, he continued to work with the development staff to raise funds for MUSC to continue its upward course. Additionally, the Board of Trustees conferred the title of President Emeritus upon him in 2000 in appreciation for his outstanding service at MUSC.

As a young oral surgeon in the early stages of his career in Charleston, Dr. Edwards was elected as President of the Coastal District Dental Society in 1967. He was a founder and charter member of the South Carolina Society of Oral and Maxillofacial Surgeons and served as its president in 1968. For his tireless service to dentistry, Dr. Edwards was honored as a Fellow in the American College of Dentists and the International College of Dentists. Dr. Edwards became a Diplomate of the American Board of Oral and Maxillofacial Surgery in 1963.

Among his many awards, Dr. Edwards was selected to receive the tenth Thomas P. Hinman Distinguished Dentist Service Medal in Atlanta in 1977. In 1994 Dr. Edwards was awarded the highest civilian honor given in South Carolina with the Order of the Palmetto from the office of Governor Carroll Campbell. Additionally in 1994, the American Dental Association awarded him their Distinguished Service Award for his outstanding service to dentistry. The South Carolina Dental Association presented Dr. Edwards in 1995 with their highest award for service to dentistry and mankind with the George P. Hoffman Award. In 2000 in Chicago, he was awarded the William John Gies Award, the highest honor given by the American College of Dentists for his contributions to the profession of dentistry. In 1997 Dr. Edwards was inducted into the South Carolina Hall of Fame at Myrtle Beach. In 2006 the MUSC Board of Trustees renamed the dental school after Dr. Edwards to where it became known as the James B. Edwards College of Dental Medicine. The Congressional Medal of Honor Society honored him in 2010 with their Distinguished Citizens Award for his fervent patriotic spirit.

Civically Dr. Jim Edwards had numerous activities and memberships. Among these were: past director of the Boy Scouts of America, Coastal Carolina Council, past member of the Board of Trustees of both Charleston Memorial Hospital and Baker Hospital, past member of the Board of Trustees, Greater Charleston YMCA, and a member of Sertoma International.

Dr. Edwards has been the recipient of 12 honorary degrees in his lifetime. Additionally he has served on 14 corporate boards and several advisory boards.

Religiously Jim Edwards was a devout member at St. Philips Episcopal Church, where he served in various capacities.

In 1951 Jim Edwards married the love of his life, Ann Darlington. They had two children: James B. Edwards, Jr. and Catharine Edwards Wingate. Upon his death on December 26, 2014, he and Ann had been married for 63 years.

Dr. Jim Edwards will always be remembered for his integrity and service to mankind. With his radiant personality, there indeed were no strangers in his life. When asked about his legacy, he thoughtfully replied, "I hope that someone will say that I loved my family and my country, and that they noticed that I always tried to do my best!"

## Dentist Needed for USC Mission Trip

The Methodist Student Network will be traveling to Misahualli near Tena in Ecuador for its Spring Break mission trip, March 5-14, 2014. Located 2 1/2 hours southeast of Quito, Misahualli is a small and safe rural community surrounded by indigenous communities in a beautiful area on the banks of a river in the Amazon rain forest. MSN will be hosted by Volunteers in Mission of the Evangelical Methodist Church of Ecuador. MSN will be engaged in several projects. A doctor and a dentist will travel with us enabling us to offer a health clinic for local residents. Students will be able to have hands on experience assisting the doctor and dentist. We will help in a construction project to add space to the church to be better able to offer social, health and Christian service to the community. Local construction experts will oversee the effort while students provide the labor. A Vacation Bible School will also be held for about 150 children throughout the week. Additionally we will make home visits to bring Christian greetings and parcels of food to struggling families. We will also be involved in a health education program for the local people. In the evening, there will be times of fellowship and worship with the youth group and congregation of the town.

We will be staying in simple accommodation and eating delicious local food. There will be opportunities for cultural exploration and site seeing and even rafting on nearby rivers. As we return to the US, we will visit Quito, the capital city of Ecuador. Quito is known as one of the most beautiful, intact colonial towns in the Western Hemisphere and includes many churches and shrines.

A large part of our being in Ecuador will be devoted to building relationships with the Ecuadorian people. Our desire is to be in solidarity with the people through times of service, socializing and worship. We want to experience Ecuador on its own terms, suspending our tendency to judge and compare. We also want to experience the Christian faith in a very different context and to see the global face of the church.

Cost of the trip is \$1,500. Participants will need to be in good health and be in possession of a passport with at least 6 months validity. International students will need to see what if any visas are required. Several immunizations will be required for those who have not traveled to a similar area previously. 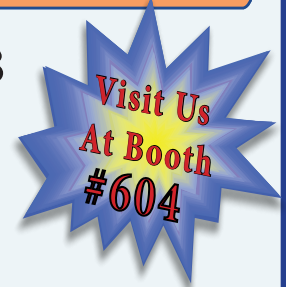

# President's Message

With the New Year many of us, both personally and professionally, make new commitments and take time to reflect on what is important in our lives and practices and resolve to recommit. On that note I believe we might all benefit from revisiting the issue of ethics and making New Year's resolutions to shine light on every decision and action we take in our practices from an ethical perspective.

The ADA provides ongoing guidance for our profession in its Code of Ethics, and divides these standards into three levels: Principles, Code of Conduct and Advisory Opinions.

At the first level, Principles, the association identifies the general values of autonomy, nonmaleficence, beneficence, justice and veracity. These goals are "aspirational" meaning they are the high bar that each of us as professionals should aspire to reach and the values that we should keep at the forefront of everything we do and every decision we make.

At the second level, Code of conduct, the ADA provides more specificity in terms of do's and don'ts – these are the behaviors and actions that we must adhere to or avoid, else we face disciplinary action and risk losing our license to practice. In some cases, failure to adhere to these conduct codes could result in legal action, however it's important to note that just because something is not technically illegal doesn't mean it's ethical – the codes of professional conduct have a significantly higher bar than the law.

At the third and final level, the ADA provides advisory opinions – interpreting the Code of Conduct to specific scenarios. This is where the ADA guidance "rubber hits the road," is the nexus between codes and practice. These opinions are ever evolving and while ethical codes of conduct have remained fairly steady the opinions have changed to fit the changing world of dentistry, including application to emerging challenges that face us at this particular time. As I indicated in my first article last month, many of us "old school" dentists will have to update our skills and techniques in order to attract and engage our newer colleagues into our ranks; likewise we will have to engage in updated means of connecting with patient communities, including social marketing campaigns designed to effectively communicate on social media such as Facebook and Groupon. While this may pose ethical dilemmas for dentists there is guidance provided within the Justice Principle Advisory opinion:

*4.E.1. Split Fees In Advertising And Marketing Services. The prohibition against a dentist's accepting or tendering rebates or split fees applies to business dealings between dentists and any third party, not just other dentists. Thus, a dentist who pays for advertising or marketing services by sharing a specified portion of the professional fees collected from prospective or actual patients with the vendor providing the advertising or marketing services is engaged in fee splitting. The prohibition against fee splitting is also applicable to the marketing of dental treatments or procedures via "social coupons" if the business arrangement between the dentist and the concern providing the marketing services for that treatment or those procedures allows the issuing company to collect the fee from the prospective patient, retain a defined percentage or portion of the revenue collected as payment for the coupon marketing service provided to the dentist and remit to the dentist the remainder of the amount collected.*

Of course we should also be aware that some jurisdictions have additional laws or regulations that impact these issues as well, however the point is that as we face new and unfamiliar questions in terms of ethical decision making. We should first look to our professional ADA guidance to support any actions that we decide to make and keep the issue of ethics at the forefront.

Finally, this month I want to remind and encourage all of us to make plans to attend the 2015 SCDA Annual Session which will be moving to Charleston, SC, April 30th through May 3rd at the Charleston Marriott on Lockwood Blvd. As I've said, I'm a Charleston girl, so I am very excited that ya'll will be coming to MY house this year!

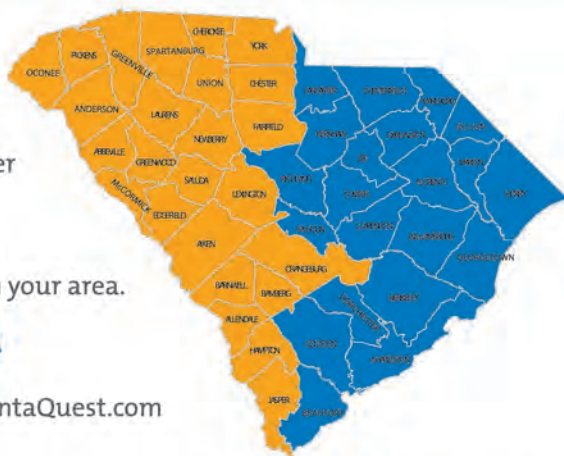

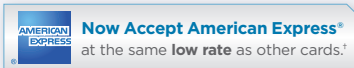

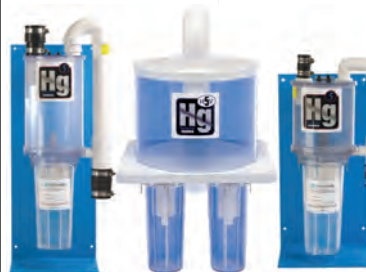
