These new features include the flexibility to obtain either 1 CE, 1.5 CE or 2.5 CE at every monthly meeting; offering lunch-time webinars on practice management topics; and holding a one-day spring meeting so that you and your dental team can acquire the newly required courses for DC licensure renewal. It is expected that these modifications to existing benefits and implementation of new programming will also aid the Society to generate new non-dues revenue streams. 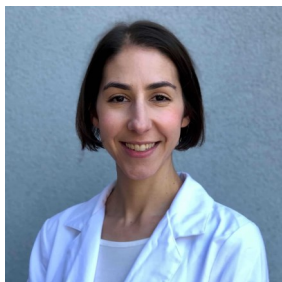

DC Water Authority Wastewater Questionnaire Due July 14

Last year, the Environmental Protection Agency (EPA) passed a rule requiring dental facilities that place or remove amalgam fillings to install an amalgam separator. In order to comply with this rule, the District of Columbia [updated regulations](#) regarding amalgam separators. Though the EPA deadline does not go into effect for three more years, the DC Water and Sewer Authority would like to identify and track compliance as soon as possible in order to ease the transition to the new regulations. To this end, they are asking all offices to complete a [wastewater questionnaire](#) before **July 14th, 2018**. This two-page questionnaire can be completed by any office staff and emailed to Elaine Wilson at elaine.wilson@dcwater.com. Alternatively, an office can complete the [One Time Compliance Report](#), which must be received by **October 12, 2020**. ADA/CVS Partnership Update



As first reported in the February issue of the DCDS Newsletter, the ADA has begun a three-year initiative with CVS Pharmacies aimed at giving consumers more resources and information on oral health. As reported by the [ADA News](#) (5/30), this partnership is already becoming a prominent feature of CVS locations all over the United States. Many CVS pharmacies have added prominent signage reminding customers about the importance of things like using mouthwash and replacing their toothbrush every 3 to 4 months. These signs also direct customers to products that have received the ADA Seal of Acceptance.

In addition to in-store signage, CVS has launched a new website, [CVS.com/ADAdental](https://www.cvs.com/ADAdental), which makes it easier for consumers to find safe and effective dental products that have received endorsements from the ADA. This website also links to the ADA's Find-A-Dentist tool, which allows consumers to search for a dentist based on geographical information and specialty. Eventually, CVS plans to install physical terminals in its locations that allow customers to search for a dentist right there in the store. Interpretation Service Keeps Practice, Patients Connected

Section 1557 of the Affordable Care Act protects people from discrimination in health care and calls for medical practices to provide interpretation and translation services for their non-English-speaking patients. The rule, which extends to dental practices, requires covered practices to post information telling patients with limited English proficiency about their right to receive communication assistance.

Dr. Margaret McGrath founded Kent Island Pediatric Dentistry in Stevensville, Maryland, eight years ago. The practice has nine operatories, three dentists and four hygienists. The dentists and staff at Kent Island Pediatric Dentistry recognize the use of medical interpretation services as not just a legal requirement, but also good business. The office uses [CyraCom](#) language services — a DCDS-endorsed service — “which improves office efficiency and patient care,” according to office manager Debbie McLanigan.

Because connection is instantaneous, the service is only a fraction of the cost of hiring an in-person interpreter, who often has time minimums and travel expenses that practices are expected to reimburse.

How to Incorporate New Materials Into Your Practice

September Monthly Meeting

The September DC Dental Society monthly meeting will be held Tuesday, September 11th at the Westin Georgetown and will feature a presentation by Dr. Nathaniel Lawson entitled “Contemporary Dental Materials: How to Incorporate New Materials Into Your Practice.”



Session Abstract

The first part of this course will teach you how to select and handle different types of ceramic materials that are currently used in dentistry that will be much less confusing than typical marketing rhetoric. We will discuss the types of ceramic materials on the market and when/how to bond to these ceramics.

The second session will cover advances in restorative materials including universal adhesives, bulk fill composites, bioactive materials, SDF, and microabrasion.
