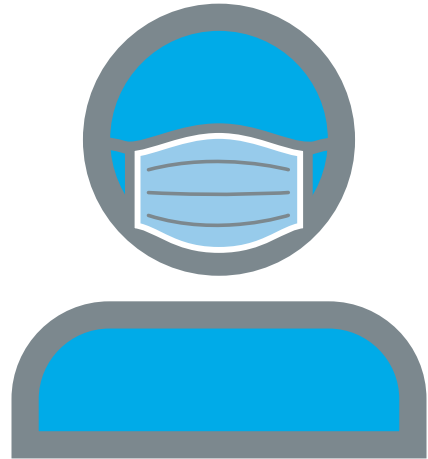

In the event Cintas is unable to obtain the Goods, Cintas shall provide prompt notice to the Customer.

Customer must purchase the Quantity of Goods set forth above, provided Cintas ships the Goods during the Commitment Shipment Period and the final sale price ("Sale Price") falls within the Sale Price Range. The Sale Price for the Goods shall be set by Cintas, in its sole discretion, once it procures the Goods.
