Dear Colleagues,

There is a large oral healthcare disparity between our U.S. service veterans and non-veterans. Many veterans while actively serving receive regular dental care. Unfortunately, when these service men and women retire they learn that dental

care is not a guaranteed benefit for veterans of the U.S. Military. They also discover how complicated and frustrating it can be to navigate the system to find out which, if any, dental services they are eligible for.

While the U.S. Department of Veterans Affairs (VA) provides some dental services, veterans must meet strict criteria for their outpatient dental care to be covered.

Only veterans with a service-connected dental disability to the head/neck, or those who are considered 100 percent disabled as a result of service, are eligible for full dental care. Non-disabled veterans who have recently served are only entitled to a one-time course of free dental care. This leaves nearly 85 percent of veterans ineligible for dental care through the VA. This means that our veterans access to oral health services is subject to their ability to pay out-of-pocket or purchase private or employer-sponsored dental insurance. As a result, many veterans without dental insurance go without any dental care.

Because of this lack of access to dental care for so many, the American Dental Association introduced "Give Veterans a Smile Day," in 2013. This is a program whereby private dentists volunteer their services to provide free care in their practices to veterans who otherwise do not have access. Here in Suffolk County, a number of our hospital based residencies also participate in this program. But commendable as such efforts are, the one-day-per-year programs are not able to sustain improvements in veterans' oral health or access to care all year round.

It is my hope that we at SCDS will begin to participate in the Veterans smile day too but also start to formulate real solutions to long term access to care for our veterans yearly. A veterans committee at SCDS is currently under development. Please join us to help solve this important veteran access to care issue.

Because this is my last time addressing you in writing as your SCDS President, I'd be remiss without sharing my gratitude. I'm very proud to have served as your president for this year. I'd like to thank my executive board of doctors William Bast, John

Guariglia, Steven Feigelson, and Radha Sachdeva-Munk. They will continue to serve you well in the years to come.

At the beginning of this year, I set goals for the component. I'm proud to say we met most of them.

Although Membership is trending down across the country, we continue to grow our market share. This is in large part to the efforts of Bill Panzarino and Dr. Claudia Mahon-Vazquez. Thank you.

We've continued to work closely with NYSDA to the benefit of our component. This synergy allows us to disseminate info to our members in a timely fashion. A big thanks goes to doctors Kevin Henner, Guenter Jonke, Paul Markowitz and others that chair and sit on councils at the state level.

Our profession has taken steps to becoming more inclusive. Here at Suffolk County, we've taken the lead in this effort. Thank you to Dr. Ivan Vazquez who chairs the Diversity, Equity and Inclusion committee at NYSDA and those that sit on this task force.

**We have come a long way in treating edentulism, yet there is much more to do - solutions in the reality of private practice.**

**COURSE CONTENT**

The past few decades of implant therapy have presented numerous restorative options to the dental professional. Reduced healing times refined surgical approaches, the emergence of digital technologies, and exciting new dental materials have enabled the dental team (surgeon, restorative dentist, and dental laboratory technician) through multi-dimensional cohesion to achieve unprecedented therapeutic results.

Soft and hard tissue replacement for intra oral anatomy must provide functional and esthetic outcomes for our patients. In the reality of clinical practice implants are not always in ideally placed, complicating the restorative scheme. The financial constraints of patients require the dental team to provide options across a broad spectrum while providing optimal results. The evolution of digital treatment planning focused on a restoratively driven surgical approach is the standard.

This discussion will revolve around treatment planning and restoration of the completely edentulous arch. Basic restorative principles for single unit and multi-unit restorations will be reviewed. Emphasis will be placed on the methodology and fabrication of a variety of dental prostheses along with rationale for each. The incorporation of all ceramic restorations, CAD - CAM technology and digital treatment will be explored. Finally, a look at restoring our most challenged patients through comprehensive therapy, with using technology and skeletal anchorage will be presented. Course Objectives:

- The specific requirements of the maxilla and mandible.
- A review of the basic design principles and fundamentals
- The application of both conventional and CAD/CAM technologies.
- The concepts of immediate loading - immediate function
- A review of different restorative options available
- The team approach to therapy and restoring Oral Health Quality of Life.

**Bio:** Dr. Frank J Tuminelli received his Dental Degree and specialty training in Prosthodontics from Fairleigh Dickenson University School of Dental Medicine. Dr. Tuminelli is a Diplomate and Director, of the American Board of Prosthodontics and is currently the Program Director of Graduate Prosthodontics at the Manhattan Veterans Administration, New York campus. He served as Program Director for Graduate Prosthodontics, New York Presbyterian Hospital at Queens from 2010 – 2016, and as the Program Director of Advanced Prosthodontics and Implantology, for the NSHLIJ Health System 2000 -2010. He is a past President of the American College of Prosthodontists, and The Greater New York Academy of Prosthodontics. He has contributed to the scientific literature authoring / coauthoring multiple scientific papers. Dr Tuminelli is the recipient of the 2017 Educator of the Year Award from the ACP. ## How can I reach you?

In our last bulletin I asked you to tell me what you're thinking. I posed a few questions, but unfortunately didn't hear back. You folks are busy, I am not offended, but a dialog or information exchange would help us move forward more intelligently. There are some members that question the "value" they get



from membership. In the past I have documented how paying attention to our partners and who we work with can really reap dividends (i.e. MLMIC clients received 3 years worth of Malpractice Premiums back in a lump payment after the Berkshire-Hathaway acquisition. There was also participation in a dental products class action lawsuit, both of these returning cash to our members. Of course there was intense hand holding and guidance through the pandemic, not just the clinical and vaccine related life saving information, but the financial advice around EIDL, Payroll Protection Plans and more. These could easily have covered dues of 10 years or more.

Now we are encouraging our members to look at the Employee Retention Credit (ERC). Whether you use the partner we have suggested or you do this with your own accountant or CPA, we urge you to look at it. Up to \$26,000 per employee is available to you.

We are also working with a firm on another class action lawsuit which offers some members the opportunity to get money back.

Some of you have not done this yet, I hope you follow through. The society was able to get a significant financial return after we applied for the ERC.

But here's an issue. We try and get the word out on these and other things, show real value and engage our members, but more often than I'd like it doesn't find its way to you.

Here are some real numbers... We send an email with this sort of information to more than 1000 members. 35% of those emails are not even opened. Of the 65% that are opened, many are never seen by the member dentist themselves. They are opened by staff. I can't quantify that number, but I know it's higher than we'd like it to be. What a shame, the one paying the dues doesn't get the insight to take advantage of the value of membership. Your return on investment is limited by this behavior. So be sure to have a look at these:




