PRESIDENT'S MESSAGE RADHA SACHDEVA-MUNK, DDS

Preparing to pass the gavel...

It is an interesting time in organized dentistry. For years the ADA has



seen declining membership as a percentage of the available pool of dentists. Some dentists don't see the value in joining the ADA. They may feel the ADA will continue to advocate for oral health in America whether or not they are a member. However, Membership is vital for our profession's survival. Having the advocacy of the ADA and NYSDA helps our voices get heard.

Lobby Day is soon approaching for New York State in March and the ADA in April. One issue to keep in our vision is the passage of licensure in New York State for dental therapists. Proposed bill S819, in favor of dental therapists, currently remains in committee. The viability of dental therapists as solution to address the oral health disparities in New York has not been fully proven. As such, NYSDA would most likely oppose any legislation targeted at creating a dental therapist provider. Further broader discussions around access to oral health care and the challenges that currently face New York must be investigated thoroughly with other solutions to the problem displayed.

The use of dental therapists has not been proven to reduce the cost of receiving dental care. Dental procedures cost the same regardless of who performs them, and there is no impact on government reimbursement rates paid through programs like Medicaid. In fact, it could be argued that the dental therapy program would ultimately increase the cost of delivery with the creation, regulation, and oversight of an additional licensed professional.

Additionally, introducing dental therapists would create a two tiered-care delivery model, with low-income patients receiving care from a less-er-trained dental therapist, while those who are more affluent will receive care from a licensed dentist. Thus, the introduction of dental therapists could result in creating a problem in health care disparities in the provision of dental services among the other challenges to dental

care delivery, including outdated reimbursement rates and unnecessary administrative burdens. These barriers make it difficult for providers to participate in plans designed for the poor and underserved. In addition to administrative and financial burdens, licensing barriers have limited the number of existing providers in New York. Addressing licensing and certification barriers for dentists, hygienists, and dental assistants needs to be a priority in New York State before new models are explored. Currently, there is only one licensed dental assistant for every 10 dentists, which is severely hampering the ability of dentists to provide care. This is where we step in to advocate for YOU, the Dental Professional, letting your main focus be on providing quality dental care to your patients.

This is my last Bulletin article as president and I am happy to report that the members of Suffolk County Dental Society are in great hands. Dr. Steven Feigelson will be taking over as president. He brings a wealth of knowledge to our society. Our Executive Director, Bill Panzarino and Executive Assistant, Carol Deerwester are both outstanding people, and are assets to the Dental Society. They are the backbone to our organization. Lastly, I would like to thank the line officers Drs. Steven Fiegelson, William Bast, Natalia Elson and John Guariglia for all their hard work and dedication. We have a bright future with them at the helm. It has truly been an honor to serve as president. See you at the next meeting!!





Fourth letter from the ADA Trustee to the NYSDA Components – January 2024 Trustee's Corner

Happy New Year to all of you and your families. It is my sincerest hope everyone enjoyed the holiday season. As we embark upon a new year, I wish all of you a healthy and successful 2024. It is a new year for your American Dental Association with many interesting things occurring in Chicago, as well as around the country.

In October, the ADA announced a new organization in collaboration with the Forsyth Institute. The new entity is now the ADA Forsyth Institute. It will dramatically change the oral health research arena with cutting edge transformative research. Ultimately, this will lead to more advanced care in the clinical care of dentistry, which will directly improve our patient's overall health. Through biological research, local and global public health outreach along with technological innovation, the ADA Forsyth Institute will set the standard for dental research around the world. The ADA Seal Program will eventually grow to investigate a much larger number of products to evaluate and decide which dental commodities deserve their approval. Elyse Cherry JD, board chair of the Forsyth Institute, gave a presentation on the organization to the ADA Board of Trustees at the October Board meeting. She discussed a storied list of accomplishments, as well as the historical background of Forsyth, which dates back more than one hundred years. The location of the new ADA Forsyth Institute will be in Somerville, Massachusetts.

I had the distinct honor of representing the ADA as a delegate at the most recent Federation Dentaire International (FDI) annual meeting last September in Sydney, Australia. The FDI World Dental Congress met and decided many of the pressing issues that deal with global oral health. Although the FDI is a small organization with headquarters in Geneva, Switzerland, it represents more than one hundred National Dental Organizations and close to one hundred countries. I have come to learn they are involved in many collaborations in the global oral health community. New policy statements on Collaboration between Oral Health Professionals and other Health Professionals, Mental Health for Oral Health Professionals and Dental Students, Tooth Wear and Alcohol as a Risk for Oral Health were decided upon. Revision of existing policy statements on Alternative Restorative Materials to Dental Amalgam, Perinatal and Infant Oral Health Care, Social and Commercial Determinants of Oral Health and Oral Health for Healthy Aging were debated and agreed upon.

The FDI is overseeing more than twenty in depth studies on research areas such as access to oral health care through primary care, the effects of free sugar on oral health and overall health, antibiotic resistance in dentistry, artificial intelligence and dental applications, consensus project on toothbrushing methods, digital cleft care and electronic health records. After many discussions to strengthen the draft of the World Health Organization's Global Oral Heath Plan (2023-2030), the revised version was incorporated with many FDI recommendations in the final language. What I have learned is the FDI punches above their weight and the ADA is an integral part of their success.

After a full year of existence, the Strategic Forecasting Committee is rounding into shape. As a committee of the House of Delegates, the SFC seated its new members following the House vote, has completed selections for the subcommittees and the action groups. The SFC has approved the Vision and Mission statements of the American Dental Association, which will be placed before the 2024 House of Delegates for final adoption. Work is now beginning to assess the value of each of the existing 171 programs at the ADA, as measured against current priorities. Discussions are also ongoing within the Action groups on a variety of critical topics. The information and opinions gathered are forwarded to the Subcommittees and finally end up at the Strategic Forecasting Committee. Any new revelations or ideas that occur in the profession will also be studied by groups that are skilled in those areas.

The Board of Trustees will take the SFC value-based recommendations of ADA programs and use them when preparing the budget and finances of the ADA. This will be done on a quarterly basis instead of annually. This correlates with mission-based accounting and making decisions on a real time basis. The ADA feels decisions made in a timelier manner will make our organization more effective and financially stable. If you are called to be on an Action group or a Subcommittee, please take us up on it and be involved in important discussions with our organization.

At my last edition of the Trustee's Corner, I mentioned the California Board of Governors decided to recalibrate and put the idea of optional ADA tripartite membership on pause. The California House of Delegates met in the middle of November and did not bring up the issue. My hope is with all the new changes happening at our ADA, there will not be any reason for California to take this issue up again. As we all know, the ADA and our profession are stronger together with the tripartite including the entire country, speaking as one for our members and the patients we serve.

I have been honored to serve as your Trustee the past year and I look forward to serving you the next three years. It has been a tremendously rewarding experience and I would like to thank all of you for the opportunity. I wish everyone a happy and successful 2024. Dental Educators Day

 $\overline{\mathrm{M}}$ ore dental schools are opening. Dental school faculty across the country are aging. As a consequence, the shortage of those who can educate the next generation of dentists is being felt nationwide, which is



why Stony Brook School of Dental Medicine sprung into action this fall, hosting its first-ever Dental Educators Day on October 5, 2023.

The occasion will be celebrated at Stony Brook on the first Thursday in October each year, held in conjunction with World Teachers' Day. Its goal? To inspire students to consider dental academia as their future career, thus making it possible for them to pass their skills and knowledge on to those aspiring to join them in the dental profession.

"By sharing the innumerable benefits of being a dental educator, we hope to inspire students to pursue such a pathway, whether their career is here at Stony Brook or elsewhere," said Patrick Lloyd, dean, Stony Brook School of Dental Medicine. "We also hope that other dental schools - in the US and beyond - recognize the value of such a forum and that they consider hosting their own dental educators event in the coming years."

With the increase in class size of many dental schools as well as the emergence of more than a dozen new dental schools in the last 15 years, the need to reinforce the faculty workforce has never been greater. According to an article in the Journal of Dental Education, over 40 percent of full-time dental faculty in the United States reported to be over 60 years of age¹. Recruitment of faculty is challenged by the misconception that private practice opportunities provide greater levels of total compensation.

"Stony Brook is uniquely positioned to help dental students interested in an academic career get a head start," said Dr. Dolores Cannella, associate dean for education at Stony Brook. "It is one of few schools in the country, if not the only school, where students can earn an education degree — a Master of Arts in

Higher Education Administration — in four years with no additional tuition costs. Also, Stony Brook's general practice residency program offers select residents a second year of training, focused on developing the skills and gaining the experience as a didactic and clinical instructor."



On the inaugural Dental Educators Day at Stony Brook, dozens of students, who are members of the school's Student American Dental Education Association or involved in research, heard the perspective of Thomas Manders, DDS, director, Division of Endodontics and advanced education program in endodontics; Sri Myneni, DDS, MS, PhD, director, advanced dental education program in periodontics; Rekha Reddy, DMD, director of oral pathology; and Christine Valestrand, DMD, director, fixed prosthodontics technique course.

"There are many tangible and intangible rewards that I have enjoyed as a faculty member at Stony Brook," said Dr. Manders, a 1991 School of Dental Medicine graduate who spent more than 25 years in private practice.

Each panelist spoke about the path that they took to dentistry and ultimately to academia, as well what they felt was the most rewarding part of their role as educators, including giving back to the profession that gave them an excellent quality of life, the ability to stay on the cutting edge of the latest technological trends in dentistry, and the many healthcare and retirement benefits available at Stony Brook.

"Follow your mentors and ask them who inspired them and what their career path was," Dr. Reddy advised the day's attendees. "One of the greatest things about working in education is that that mentorship continues. You stay on top of the latest developments in dentistry. You have to take CE courses in private practice, but by working in academia, it's almost like you have CE every day. You can continue to wear those multiple hats - doing research, serving as a mentor, and giving back to the future of dentistry by sharing your passion with others."

All of the presenters acknowledged that it was the variety in their days that kept them enthused and excited about their careers in dental education. "No two days are ever the same," was the common refrain. Adding to this was the yearly infusion of a new crop of students and residents who were eager to learn and asking all sorts of questions - helping keep everyone up to date on the latest discoveries and most advanced technologies.

"We're going to take a lead on promoting opportunities in dental education, so that our school continues to recruit the very best students and residents, by having the very best faculty," remarked Dean Lloyd. "Let's hope other schools catch on and do their part in preparing the next generation of dental educators – the future of our profession depends on it."

Our Suffolk delegates and alternates worked hard to prepare, debate and vote on the issues at this year's SmileCon Meeting in Orlando, Florida. 
