COVID-19 Vaccines and Vaccinator Training:

Information regarding **Vaccine availability and registration** has been provided to our members through our Suffolk County Dental Society Executive Director as well as links provided on the NYSDA website. We are well aware that it is extremely difficult to obtain appointments at this time, however Bill and Carol will continue to notify the members regarding Vaccine availability. Check your e-mails for information and query the NYSDA website often to see if appointments are available.

If you are interested in becoming a Vaccinator you can sign-up and find all the links for training on the NYSDA website. There is a statewide volunteer registry in place for New York State - [ServNY](#). This is an emergency management registry that was created after the events of 9/11. Members who register will be linked to their local medical reserve corps. After registering, you will be contacted directly through [ServNY](#) to volunteer at various distribution sites run by local departments of health. Dentists and Dental Students (with one year of clinical experience) are eligible to

administer the vaccine after receiving mandatory training (infection control, PPE usage, and CPR).

We are extremely proud of the **Stony Brook School of Dental Medicine students** who have been administering the vaccine at the Stony Brook Campus. These students have not only continued their studies but have found time to give back. Thank you!

COVID-19 resources may be found on the NYSDA website and can answer many of your questions including: current quarantine restrictions, guidance if a staff member or patient tests positive, an Office Safety Marketing Toolkit and much more. TAX TIPS FOR DENTISTS by Stuart A. Sinclair, CPA

If you are not ready with your personal income taxes by April 15, 2021 you should file a federal extension form 4868 and a NY State extension form IT370. You should pay in what you think you will owe, or you will be charged interest on the shortage.

Corporations are due March 15, 2021, unless you are a C-corporation which is due April 15, 2021.

Those extension form numbers are federal 7004 and NY CT5.

What is the role of the Dental Profession in promoting the Covid-19 vaccination to our patients?



Vaccinations, according to the World Health Organization, remain one of the most important public health measures for improving the world's health of our time. Vaccinations protect a person from illness but also help keep disease from spreading. The benefits include saving millions of lives each year. We currently have 20 vaccines to prevent

life-threatening diseases, helping people of all ages live longer and healthier lives.

Immunizations are our best protection against these diseases, but what can we do or say as a profession to help promote vaccinations for our patients?

In the Preamble of the Code, it states that dentists follow high ethical standards which have the benefit of the patient as their primary goal. Dentists possess knowledge, technical competence and also those traits of character that foster adherence to ethical principles. Qualities of honesty, compassion, kindness, integrity, fairness and charity are part of our ethical education and practice of dentistry which define us as a profession.

The ethical dentist strives to do what is right and good. Our profession has greatly improved in promoting overall health. C. Everett Koop, former Surgeon General stated that "You're not healthy without good oral health". We continue to place the patient front and center with respect to overall health through communication and collaboration with our medical colleagues. We are moving the dental profession more than ever on the importance of health, illness prevention. Research studies continue to show a link between oral manifestations and systemic disease.

Blood pressure monitoring, diabetes evaluation, osteopenia and osteoporosis education not to mention sleep apnea evaluations are just a few medical issues we see and discuss in our offices daily. Everyone in dentistry needs to play a preventive role during a pandemic or not. With persistent education and proper communication, our patients will regain their health and establish a sense of normalcy much sooner.

Section 3 Principle: Beneficence ("Do Good") The dentist has a duty to promote the patient's welfare. This principle expresses the concept that professionals have a duty to act for the benefit of others. Under this principle, the dentist's primary obligation is service to the patient and the public-at-large.

Immunizations are just another way to help all patients remain as healthy as possible. Dentists remain a cru-

cial partner to increase participation for the Covid-19 vaccine. We have this opportunity to help our communities and we should. As many of us already know, legislation has allowed dentists to administer Covid-19 vaccines throughout the country and more states, Oregon in particular is allowing dentists to administer vaccines more broadly. Dentists see a variety of patients each and every day. Many reports say that patients frequent their dentist more than their physician on an annual basis. We should continue to promote the vaccinations of as many patients as we can to promote essential health care to all. Remember that dentists are a part of the health care team and willing to help wherever and whenever we can. Remember, balancing the ethical, moral and legal obligations during these uncertain times is a challenge to all of us, but at the end of the day let's keep the main focus on protecting our patients, staff, and ourselves. *{Dr. Jonke is the Past Chair of the NYS-DA Council on Ethics and is currently serving on the ADA Council on Ethics, Bylaws and Judicial Affairs.}*
