Title: Challenges of Replacing Missing Laterals Predictably: A Restorative Dentist’s Perspective

Synopsis: Restoring maxillary missing laterals is a great challenge, in the best-case scenarios. Even with today’s advances in technology, why are these cases so challenging to manage??? “*There are teenagers attached to them,*” who are continuing to grow and change, even when we think we have them “in a holding pattern.” This lecture will present the challenges of these cases and describe pathways to help the patients and parents get to a result they can manage, using implants or natural teeth. By manage, Dr. Rogers means things still change in the years beyond “delivery”.
