The Long Road Amending the McCarran-Ferguson Act By Dr. Scott Cayouette, SCDA President



What is the McCarran-Ferguson Act and why is it important to the citizens of this United States of America and to health professionals, including dentists?! Let me walk you down "memory lane" and give you the necessary background. The McCarran-Ferguson Act was made into law by Congress in 1945. In 1944 the Supreme Court heard the case United States v. South-Eastern Underwriters Association and ruled that "an insurance company that conducted substantial business across state lines was engaged in interstate commerce and thus was subject to federal antitrust

regulations." So, then Congress comes back in 1945 and passes into law the McCarran-Ferguson Act, which exempts the business of insurance from some of the federal anti-trust laws.

The ADA recognizes that the antitrust exemptions given to the health insurance companies through the McCarran-Ferguson Act have likely caused federal agencies to avoid enforcing even those federal antitrust provisions that do apply. The official ADA statement issued by Dr. Jeffrey M. Cole in February 2019 sums up why the repeal is necessary, "If health insurance companies had to follow all of the antitrust laws when setting rates and designing coverage, it would increase competition among the companies that insure both individual customers and purchasers of large group policies." It makes sense that this narrow repeal just applying to health insurance companies, including dental insurance, would inject greater consumer choice and more innovation through insurance company competition which probably would result in lower prices. The ADA has advocated on Capitol Hill for over 20 years to repeal the antitrust exemption for the health insurance industry. I can honestly tell you for the last 3 years the ADA with its lobbying team have worked tirelessly with members of Congress to make some headway to get McCarran-Ferguson Amended. In fact, in 2017 Rep. Paul Gosar (R-AZ) introduced a Bill that had overwhelming bipartisan support and passed the House of Representatives 416-7. However, the Senate would never take up the issue so it ended up going nowhere. Now as dentists this is our BEST CHANCE EVER with The Competitive Health Insurance Reform Act of 2019 (S. 350/H.R. 1418) being introduced February 6, 2019. In the Senate S. 350 was introduced by Sen. Daines (R-MT) and Sen. Leahy (D-VT) and in the House of Representatives H.R. 1418 was introduced by Rep. DeFazio (D-OR) and Rep. Gosar (R-AZ). This is the first Bipartisan and Bicameral Bill championed by the ADA Legislative Team. If this passes the Senate and the House of Representatives, it will repeal the antitrust exemption for health and dental insurance only. This repeal will help inject more competition into the health/dental insurance marketplace since the FTC and the Justice Department would be able to enforce the full range of federal antitrust laws against health/dental insurance companies that engage in anticompetitive conduct.

Here is a list of South Carolina's Senators and Representatives: Sen. Tim Scott, Sen. Lindsey Graham, Rep. Joe Wilson, Rep. Jeff Duncan, Rep. Ralph Norman, Rep. Tom Rice, Rep. William Timmons IV, Rep. Joe Cunningham, and Rep. James Clyburn. You may ask why am I giving you this information? Well it is time for you as grass roots members to make a difference and get involved, especially when this is an election year! 16th District Trustee Report

At this meeting, we were joined, as is our usual practice, with the chair of our New Dentist Committee. Dr. Jarvis' contributions are always valuable and appreciated. We were also joined by the president from ASDA, Mr. Craig McKenzie, who also provided valuable insights to us. Seeking out diverse viewpoints, especially from younger members, strengthens our deliberations.

This year, we took important and necessary action to assure the future viability of our Foundation. The Foundation will continue to exist and be a stronger, more focused Foundation. As we transition to a Foundation focused on scientific research, we examined how the transition is progressing. Some major philanthropic activities will shift to the ADA, although the endowed funds will remain housed in the Foundation. The ADA will manage Give Kids a Smile, Tiny Smiles and the charitable assistance grants through a service agreement between the ADA and the Foundation. The transition Board is working toward refocusing the Foundation and seeking to ascertain during the next year, what the financial commitment of the ADA will be in future years.

Our Science Institute will be moved into the recently refocused Foundation beginning next year. The Foundation will likely change its name to better reflect its new purpose. The change in focus of the Foundation will allow us to maximize our efforts in science both at our Chicago office and at the Foundation's research center in Maryland. Our Council on Scientific Affairs will continue as an agency of the ADA and it will now work closely with the new Board of the Foundation. The work to complete this transition is moving forward. The Foundation is currently being overseen by a transition Board made up of the ADA President, President-Elect, Executive Director and one trustee, Dr. Klemmedson. The plan is to have the new Board of Directors appointed by the ADA Board in the coming months when the bylaws are approved, with the goal to make them effective on January 1, 2020.

A responsibility of the Board is to monitor our progress under the strategic plan. A key tool used by the Board to fulfill this responsibility is the Quarterly Management Report. At this meeting, Dr. O'Loughlin presented the latest QMR to us for our review. We are expecting to finish the year and the term of our current strategic plan in a strong position. A challenge the ADA is facing is that a large cohort of our members is retiring. Despite this, our net membership numbers are improving. We now make state-specific membership data available to you and our state societies. The key effort is to better collaborate with the states, because we recognize that most membership decisions are made at the state and local levels. Of course, we have addressed decreasing dues revenues as an additional stressor. This is largely attributable to dues discounting. The dues streamlining proposal going to the House will help in this regard.

The issue of student debt has been an area of focus for us for quite some time. One key offering for students in debt is Laurel Road's refinancing services. This program began in 2015. We received an update on Laurel Road at this meeting. The ADA does not profit from this program. Rather, any potential profit is used to reduce the interest rate offered to our members. We remain committed to maintaining this program as a member benefit. Because of the importance of the student debt issue, the Laurel Road program strongly aligns with the membership goal of both our current and next strategic plan. It offers a concrete financial benefit to those who participate. With our contract with Laurel Road expiring next summer, we will be evaluating the program and considering Laurel Road and other finance companies for the future.

We approved a proposal to shift the refinancing program with Laurel Road, or some future provider, to ADABEI. ADABEI currently manages our corporate endorsement relationships and, for that reason, would be a good fit for this program. We have communicated our strong desire to the ADABEI board to maintain the program as a member benefit and not to generate profit.

The Board has the authority and responsibility to approve any new journal of the Association. At this meeting we approved the creation of JADA Open, a new open-access journal. Open access refers to a revenue model in which the cost of publication is borne by the authors or the funding agencies, who pay article-processing charges, rather than by readers and subscribing institutions. The articles themselves are freely available. More and more private, government and university funding sources are requiring that research results be published in open-access journals. JADA Open will allow us to focus on evolving areas of research, in addition to research which is required to be published in open access journals. It is


important to note that JADA Open will be rigorously peer reviewed, as JADA is. Further, JADA Open will be an additional journal and JADA itself will remain. Our next step will be to begin a search for an Editor in Chief and an Editorial Board.


For a number of years now, our annual meeting has been experiencing declines in attendance and exhibitor participation, although still being profitable. Recognizing this, the Board's Committee on Annual Meetings (CAM) has initiated a project to examine all aspects of our meeting to deliver new and more engaging experiences and to enhance profitability. This is necessary given the very competitive environment for dental meetings. This project will be a major undertaking and we look forward to new insights to be generated by it. The Board will closely monitor it as the work progresses.

Mr. McKenzie, president of ASDA, provided us a report on ASDA's strategic plan. ASDA is focusing on leadership development, financial stability, member value and increasing dental school support of student involvement with ASDA. A high percentage of ASDA members see value in their membership. Levels of engagement and recognition that ASDA promotes wellness were particularly high. ASDA's advocacy efforts align with ADA efforts. Priorities are licensure reform, student debt, mid-level providers and fluoride. The ADA and ASDA clearly share some common ground and we all look forward to working together.

We received an update on ADAPT. The ADAPT board is planning on aggressively pursuing expansion of the pilot. Currently, the pilot is operating in Wisconsin and Maine. When this expansion occurs, it will require changes to ADAPT's technology platform and additional staff support. ADAPT will return to us with updates as this work progresses. Talking points will be provided to you to assist in communicating about this program.

Mr. Graham provided his regular report on our advocacy efforts. He informed us that we will withdraw from the ad hoc coalition advocating for medically necessary dental treatment covered under Medicare. The coalition has taken positions outside of our policy. For that reason CGA recommended withdrawal from that coalition. On McCarran Ferguson repeal, work continues and we are hopeful of success in the House of Representatives this fall. Outreach continues on the Senate side. Mr. Graham did inform us that the American Hospital Association has joined our coalition in support of this effort.

EPA Amalgam Recycling Rule



All non-exempt practitioners must install a compliant separator by July 14, 2020. Newly opened offices that begin operating on or after July 14, 2017 must be in compliance immediately.

Must file a One-Time Compliance Report within 90 days of installation.



SEPARATOR ALREADY INSTALLED?

Good until June 14, 2027 or unit needs to be replaced, whichever comes first.

Must file a One-Time Compliance Report by October 12, 2020 or 90 days after transfer of ownership.

EXEMPT FROM INSTALLING

 Dentists exclusively practicing in one of these specialties: oral pathology; oral + maxillofacial radiology; oral + maxillofacial surgery; orthodontics; periodontics; prosthodontics.

No further action required.

2) Wastewater discharges from a mobile dental unit or into a private septic system.

No further action required.

3) Dentists who do not place amalgam and do not remove amalgam except in limited emergency or unplanned, unanticipated circumstances, and who certify as such (estimated less than 5%).

Must file a One-Time Compliance Report by October 12, 2020 or 90 days after transfer of ownership. Keep on record for lifetime of practice ownership.

Installed amalgam separators must comply with the following best management practices:

- 1. File a One-Time Compliance Report. Keep on record for lifetime of ownership.
- 2. Monitor according to manufacturer's recommendation.
- 3. Replace/Repair if malfunctioning according to manufacturer's instructions within 10 business days of discovering defect.
- 4. Maintain by replacing amalgam retaining cartridge, separator canister or units as directed by manufacturer or when the collection unit reaches capacity, whichever comes first.
- 5. No use of oxidizing, acidic cleaners when flushing dental unit water lines, chair-side traps and vacuum lines. Therefore no bleach, chlorine, iodine and peroxide cleaning agents that have a pH of lower than 6 or greater than 8.

Must maintain records on site for 3 years of:


- 1. Any reports filed
- 2. A visual inspection log
- 3. Documentation of any repair or replacement
- 4. Disposal records
- 5. Manufacturer's current operating manual for the device in place
