Phase 2 Guidelines Released By D.C. Health

The ADA is NOT charging for the masks themselves as they were provided by FEMA at no cost. The ADA is NOT profiting on these masks - charging only to recoup actual costs to receive, re-package, ship via UPS through our fulfillment partner PBD and credit card / processing fees.

ADA FDC 2020 to move online in light of COVID-19 pandemic

The American Dental Association and Florida Dental Association have decided not to move forward with the ADA FDC Annual Meeting as an in-person convention in light of the COVID-19 pandemic.

The ADA Board of Trustees voted June 12 to cancel the in-person gathering. The associations are exploring virtual options for the meeting and will share more information as it becomes available.


"It was a difficult discussion, but our members and their concerns are our first priority. The health and safety of our dental family is at the heart of this decision," said Dr. Nan Tertel, general chair of ADA FDC 2020. "We look forward to virtual possibilities in 2020 and meeting face to face in Las Vegas 2021."

The ADA and FDA made their decision based on extensive research, careful deliberation and feedback from their members and past meeting attendees, according to emails the ADA FDC 2020 team sent to ADA members and meeting attendees. The annual meeting originally was planned for Oct. 15-18 in Orlando, FL.

Testing Dental Employees for Antibodies and Antigens

Can an employer require employees to undergo antibody testing for COVID-19? What about antigen testing? With respect to antibody testing, the short answer is no. According to the most recent guide from the US Equal Opportunity Commission ("EEOC"), an antibody test at this time does not meet the Title I of Americans with Disabilities Act's ("ADA") "job related and consistent with business necessity" standard for medical examinations or inquiries for current employees. Therefore, requiring antibody testing before allowing employees to re-enter the workplace is not allowed under the ADA.

HPI research brief, webinar share dental spending projections for 2020 and 2021

Dental spending among Americans will continue to decline in 2020 before making a comeback in 2021, according to an updated research brief from the ADA Health Policy Institute modeling the impact of COVID-19 on dental spending.

Since the publication of HPI's dental spending brief in April, dental practice activity in terms of patient volume and practice employment has rebounded, though it is still below pre-COVID-19 levels.

Meet the New DCDS Officers and Board Members




Dr. Pierre Cartier - President-Elect

After graduating from the University of Kentucky College of Dentistry, Dr. Cartier served in the US Air Force Dental Corps at Joint Base Bolling-Andrews, where he completed an Advanced Education in General Dentistry residency in 2006. Following his service to the Air Force, he served as a civilian dentist at Walter Reed Army Medical Center and later held positions in the private sector. In 2014, he accepted a role in managing the District of Columbia's Oral Health Program after earning an MPH from The George Washington University's Milken Institute School of Public Health, where he holds an adjunct faculty appointment in the Department of Epidemiology. Currently, he is an attending dentist at the DC VA Medical Center, where he maintains a comprehensive general dentistry practice and teaches in the General Practice Residency.

Organized dentistry has been an integral component of his career since 2001. In dental school, he served as a regional representative for the American Dental Education Association's Council of Students. Later, he facilitated educational programming for the DC Academy of General Dentistry from 2011-2014. A DCDS member since 2014, he currently serves on the DCDS and Foundation boards and as the Public Policy Chair.

Dr. Ioana "Anna" Bettios - Vice President

Dr. Bettios is a Professor and Chair of the Department of Prosthodontics at Howard University College of Dentistry. She received her Bachelors of Sciences and Doctorate of Dental Surgery Degrees at the University of Maryland; she joined the military service during Dental School, and retired after 30 years of highly decorated service. Dr. Bettios completed a Clinical Fellowship program in Prosthodontics in San Diego, CA, and a Residency program in Prosthodontics at the Naval Postgraduate School in Bethesda, MD, and a Master's Degree in Health Sciences at the George Washington University. During her military service, she held several Senior Healthcare Executive leadership positions, in the Mid-Atlantic and the Pacific theaters. She authored many healthcare policies for the Department of Defense at the Bureau of Medicine and Surgery for the Surgeon General of the Navy, and Health Affairs. During her military and civilian career, she has Chaired many Healthcare Committees and has lectured to large scale audiences worldwide. She has Chaired the Membership Committee at the DC Dental Society with four ADA awards the past four years.



An active member of the American College of Prosthodontists Digital Dentistry Task Force with publication in April 2018 for the Digital Curriculum for the Dental Schools. She is a Diplomate of the American Board of Prosthodontics, a Fellow of the American College of Dentists, the International College of Dentists, and the American College of Prosthodontists; a member of the ADA, the International College of Prosthodontists, and the Academy of Osseointegration. Dr. Bettios is a passionate clinician volunteer with many missions with over 1200 hours for the Capital Area Red Cross Chapter, the Northern Virginia Dental Society, the Maryland Mission of Mercy, and Remote Area Medical Virginia Section with thousands of dollars of dental services provided to local underserved communities every year.

Dr. Eugene Giannini - Treasurer

Dr Giannini was a student at Georgetown Dental School and a two term National Vice President of the American Student Dental Association. After graduation he attended general practice residency in New York. He returned to DC and began his involvement with DCDS by serving on several committees. These culminated in his selection as Chairman of the Nation's Capital Dental Meeting in 2004 and later to serve as President in 2006.



Dr. Giannini was later appointed to the ADA's Council on Communication in 2006 for a four year term and also served as the council's consultant to the ADA's Council on Governmental Affairs. He was in the District of Columbia Board of Dentistry's Anesthesia Task Force in 2009 and have served in an advisory position to the board. In 2014, he chaired the Society's Executive Director Search and he currently serves as a member of the DCDS Public Policy Committee and the DC Dental Political Action Committee.

Dr. Sally Cram- Secretary



Dr. Cram has been a member of the DC dental community for over 30 years. Upon graduation from Georgetown University School of Dentistry and the University of Texas Health Science Center's graduate periodontal training program, she established a private periodontal practice here in Washington, DC in 1988. She held previous teaching positions at Georgetown University School of Dentistry and Northern Virginia Community College's Dental Hygiene Program. She has been very active in organized dentistry during and after graduation from dental school. She is a past president of the D.C. Dental Society, having served on almost every committee over the years. And is currently the President of the D.C. Dental Society's Foundation.

Dr. Cram has also been involved at the national level as a spokesperson and consumer advisor for the American Dental Association since 2001 and served as a delegate and alternate delegate to the ADA's House of Delegates since 2004. Dr. McGorry is a General Dentist practicing as an associate at Markowitz Dental in DuPont Circle. She graduated from The Ohio State University, College of Dentistry in 2016. While at OSU, she served as secretary of the American Student Dental Association (ASDA) chapter for three years. In addition, she served as the Student Liaison to the Ohio Dental Association's Education Committee for two years and helped plan the Annual Session. She lobbied on Capitol Hill on behalf of ASDA in 2014 to help promote bills that would benefit new dentists and the dental profession as a whole.



After graduating, Dr. McGorry completed a yearlong GPR at the Washington D.C. Veterans Affairs Medical Center and joined the DC Dental Society at that time. She is currently serving on the Education Committee of the DC Dental Society as well as on the Education Committee for the American Academy of Dental Sleep Medicine. She has a special interest in the treatment of primary snoring and obstructive sleep apnea with oral appliance therapy. She earned the Qualified Dentist Designation through the American Academy of Dental Sleep Medicine in 2018 and am set to gain diplomate status by Fall 2020.

Dr. Kim Menhinick - Board Member



Born and raised in British Columbia, Canada, she moved to Cleveland Ohio in 1993 to work towards completing a D.D.S at Case Western Reserve University. 
